Detail of Report

- **1. Introduction.** This is the second Trustees' report. During the reporting period, the Trust has delivered a minor infrastructure project, continued the initiative for a Community Calendar and started a monthly Sunday Market during the summer months (April September).
- **2. What We Do.** The Isle of Bute Trust is an initiative to provide an opportunity for the many people around the world who love our island to help local projects. We have created an ongoing fund, administered by a board of trustees, which will be used to help local organisations, including small businesses and start-ups.

- **4. Finance.** We were enormously lucky, early in our existence, to receive a sizeable bequest from the Estate of the late Commander Hamilton. This has allowed us to operate effectively right

from the outset, and we are incredibly grateful for this generosity. We are grateful for the cooperation and match funding provided by "For Bute" in respect of the Ambulance Shelter project. We are also very appreciative for the grant of £1k from Argyll & Bute Council in support of the same project.

5. What Have We Done In the last 12 Months?

- a. **Bute Calendar**. We have continued the popular monthly calendar throughout the reporting period. Linked to its online version, the Calendar has proved popular with tourists and locals alike.
- b. **Ambulance Shelter**. As stated in our 2016 report, the major activity in the last 12 months has been the delivery of the Ambulance shelter. This was successfully handed over to the community in December 2016. Details are here: http://www.isleofbutetrust.org.uk/ambulance-shelter/
- c. **Sunday Market "Market at the Pier".** Since April 17, the Trust has operated a monthly Sunday Market on the mid -pier in Rothesay. This has proved increasingly popular, and we have taken a licence to operate this for the next 2 years

6. Future Activities.

- a. We will continue to operate the Ambulance Shelter.
- b. We will also continue to provide Bute Calendar a valuable local service.
- c. In August 2017, we will run an event as a tourist attraction. This will be a model railway weekend, which will hopefully address one of the 2016 Charrette outcomes "make better use of the Promenade in Rothesay".
- d. We will seek to increase our online profile and will recruit a digital volunteer.
- e. Conscious that we have drawn heavily on our financial reserves in this period, we will seek to raise funds from external sources.
